**3<sup>rd</sup> MISS EYYOU/EENOU ISKWAAU (MEEI) pageant contest**  
**Waswanipi, QC – Saturday, April 17, 2021**

The Eeyou/Eenou Iskwaau (MEEI) pageant aims to empower our Miss Eeyou/Eenou Iskwaau by taking pride in their culture and give one of them the opportunity of a lifetime to either take part in the *Miss Indian World* (MIW) pageant or to attend various National/International conferences.

The grand prize of the MEEI contest will be, at the winner's option, either an entry in the MIW pageant (which will take place during the Gathering of Nations PowWow in Albuquerque, New Mexico in April 2022) or the opportunity to attend various National/International conferences from April 2021 through April 2023. To claim the grand prize, the winning candidate has to meet the either the MIW eligibility criteria of Miss Eeyou/Eenou Iskwaau criteria, depending on the choice of the grand prize. In the case our Miss Eeyou/Eenou Iskwaau is crowned at MIW the 1<sup>st</sup> runner up will than become Miss Eeyou/Eenou Iskwaau .

While the MIW rules and criteria exclude certain women from participation, it is not CWEIA's intent to undervalue the mothers and wives of this Nation. In our traditional views, women are the backbone of our families and Nation. It is, however, our understanding that a candidate who wins the MIW title will be required to travel and speak at various events, which can be difficult for those who are dedicated to their responsibilities as mothers and wives.

It is Cree Women of Eeyou Istchee's (CWEIA) mission to value and empower women of all backgrounds as a way to strengthen our communities and our Nation. One of our main goals at CWEIA is to create a variety of spaces that embrace what we collectively uphold and value as Eeyou/Eenou Iskwaau. In this case, the MEEI pageant is specifically aimed at the young women in our membership who are seeking experiences that will shape them into stronger, and more outspoken leaders.

### 1. MISS EYYOU/EENOU ISKWAUU ELIGIBILITY CRITERIA

- You must be a beneficiary member of any of the communities within Eeyou Istchee, as well as a resident within Eeyou Istchee or a Post-Secondary Student residing outside Eeyou Istchee.
- You must be a member of Cree Women of Eeyou Istchee Association.
- You must be at least Sixteen (16) years of age and no older than thirty-five (35) years of age by April 17, 2021.
- You have NOT been convicted of any criminal offense. There are no criminal charges presently pending against you.
- You cannot abuse alcohol or drugs, must maintain and display a sober lifestyle.
- You are in good health and can, to the best of your knowledge, participate fully and without limitation in any program activities. Any current medical condition or disability will not prevent you from performing your role and responsibilities during your reign.
- You must be knowledgeable about, or in the process of acquiring knowledge of, your culture, history, values, traditions and issues of your First Nation and current issues of your community and all of Eeyou Istchee.
- You have obtained a high school diploma or General Education Diploma (GED), or currently attending high school, GED classes, iiyiyutuwin knowledge, college or technical school or plan to continue your education in the near future.
- You must not have previously held the title of Miss Eeyou/Eenou Nation.
- You must be willing and able to communicate with the public and make yourself available to

attend some of CWEIA's events upon request.

- You must make yourself available to participate in all program pageant activities.
- You may be required to be a part of the CWEIA Board of Directors.
- You must comply with all program requirements and the MEEI agreement. If you choose participation in the MIW pageant as the grand prize option for the MEEI pageant, you must also comply with the MIW criteria and agreement. See agreements in Annex.
- Participation is limited to one (1) representative per community. They can be acclaimed during a local pageant or, if there is no local pageant, nominated by a community member. If there is more than one (1) representative nominated per community, the local Youth Council and/or the Local Women's Association's will select the participant they wish to send to the pageant.

## **2. CODE OF CONDUCT & DUTIES FOR PAGEANT WINNER, 1<sup>ST</sup> AND 2<sup>ND</sup> RUNNER-UP**

Miss Eeyou/Eenou Iskwaau and all contestants represent themselves, their families, and all Eeyou/Eenou people in Eeyou Istchee and are expected to uphold their titles with respect, honor and dignity. Miss Eeyou/Eenou Iskwaau will always be a positive role model and is expected to conduct herself at all times in a manner that portrays self-respect

Participants must read the following carefully to understand that MEEI winner will need to adhere to the following regulations:

### **OPTION 1: MISS EEYOU/EENOU ISKWAAU - Code of Conduct:**

1. Maintain a positive & healthy lifestyle by not abusing alcohol or drugs.
2. Incarceration or conviction of a crime shall be immediate cause for relinquishment of the MEEI title. In the event of relinquishment all benefits, royalties, gifts, and honors derived from the program and reign shall be returned to the Cree Women of Eeyou Istchee Association and offered to the 1<sup>st</sup> or 2<sup>nd</sup> runner-up.
3. Preferably, must maintain Eeyou Istchee residency throughout the years of service, (if not attending post secondary studies or for work).
4. Traditional dress must reflect the customs of Eeyou/Eenou that they represent.  
As MEEI winner, you will be required to travel and attend public events. You may be required to travel with a chaperone at times. CWEIA will inform you of travel or events to attend.
5. Conduct fundraising activities to attend conferences and events.

**Duties:**

1. Shall serve for a period of two (2) years.
2. Miss Eeyou/Eenou Iskwaau will appear on time at all scheduled events. Should an emergency arise which prevents an appearance, immediate notification will be made to the Program Coordinator of Cree Women of Eeyou Istchee Association (CWEIA).
3. Miss Eeyou/Eenou Iskwaau is responsible for the care and safe-keeping of the crown and sash during her reign and is financially responsible in the event of loss or damage to the crown. The crown and the sash are perpetual, which will be handed down to the next MEEI and remains the property of CWEIA.
4. Miss Eeyou/Eenou Iskwaau is considered a team member of the MEEI Planning Committee under CWEIA and will present written reports upon request to CWEIA during regular scheduled meetings.
5. Miss Eeyou/Eenou Iskwaau will take an active role in identifying and encouraging future participants in the MEEI Regional Pageant.
6. Attend the next MEEI event by mentoring the participants and share about her experience and involvement during her reign.

**OPTION 2: MISS INDIAN WORLD - Code of Conduct:****Code of Conduct:**

1. Preferably, must maintain Eeyou Istchee residency throughout the years of service.
2. Traditional dress must reflect the customs of Eeyou/Eenou that they represent.
3. As MEEN winner, you will be required to travel and attend public events. You may be required to travel with a chaperone at times. CWEIA will inform you of travel or events to attend.
4. Must not marry or cohabitate during the year of their reign.
5. Must not become pregnant during the year of their reign.
6. Must not be seen in bars, frequent liquor establishments, use alcohol or illegal drugs, including tobacco products or use profanity at any time during their reign.
7. Pregnancy, incarceration or conviction of a crime shall be immediate cause for relinquishment of Miss Eeyou/Eenou Nation title. In the event of relinquishment all benefits, royalties, gifts, and honors derived from the program and reign shall be returned to the Miss Eeyou/Eenou Nation Committee and offer to the 1<sup>st</sup> or 2<sup>nd</sup> runner-up

**Duties:**

1. Sell 500 raffle tickets for the Miss Indian World Entry.
2. Shall serve for a period of two (2) years.
3. Miss Eeyou/Eenou Iskwaau will appear on time at all scheduled events. Should an emergency arise which prevents an appearance, immediate notification will be made to the Miss Eeyou/Eenou Iskwaau Committee under Cree Women of Eeyou Istchee.
4. Miss Eeyou/Eenou Iskwaau is responsible for the care and safe-keeping of the crown and

sash during her reign and is financially responsible in the event of loss or damage to the crown. The crown and the sash are a perpetual crown, which will be handed down to the next Miss Eeyou/Eenou Iskwaau and remains the property of the Miss Eeyou/Eenou Iskwaau Planning Committee.

5. Miss Eeyou/Eenou Iskwaau is considered a team member of the Miss Eeyou/Eenou Iskwaau Planning Committee under CWEIA and will present a written quarterly report to the Miss Eeyou/Eenou Iskwaau Planning Committee during regular scheduled meetings.
6. Miss Eeyou/Eenou Iskwaau will take an active role in identifying and encouraging future participants in the Miss Eeyou/Eenou Iskwaau Regional Pageant.
7. Attend the next MEEI event by mentoring the participants and share about her experience and involvement during her

### **3. JUDGING CATEGORIES FOR MEEI PAGEANT**

*Miss Eeyou/Eenou Iskwaau Pageant participants must be **on time** for all scheduled events (i.e., workshops, activities, rehearsals, etc.) unless advance permission is granted for an absence by CWEIA.*

#### **SOCIAL ETIQUETTE AND APPEARANCE (Every Session)**

Miss Eeyou/Eenou Iskwaau must show the judges that she can interact and converse with the crowd. If crowned MEEI, she will be required to attend public events and she must interact with the people.

#### **1. PERSONAL INTERVIEW (Session 1) March 17, 2021**

The participant will have an interview with the judges, they will be judged on how they present themselves and how they react and respond to questions.

#### **2. TRADITIONAL DRESS (Session 1)**

You must provide a description of your traditional dress. This description is used to write the script for the traditional dress portion of the evening program. Include any information you feel is relevant, such as the methods used to make the clothing, the meaning of certain articles, or celebrations that the dress is worn for.

#### **3. WRITTEN ESSAY (Session 1)**

You must submit an essay topic choice based on one (1) of the following general topics with an Executive Summary of not more than 150 words:

1. Two-Spirited (LGBTQ2) Community
2. Preservation of Cree Culture and Language
3. Mental Health or Well-Being of Indigenous People

#### 4. Physical Structure or Social Determinants of the Eeyou Istchee

#### 4. TALENT PRESENTATION ( Session 2) March 24, 2021

A three to five-minute talent presentation is required. The talent presentation may be either traditional or contemporary in nature (i.e., singing, dancing, explanation of a tradition of your nation, etc). You must provide a mp4 format video of your talent.

No other individual will be allowed on stage/video during the talent presentation. Any accompaniment must be off stage. Presentations, which are over five minutes, will be penalized 10 points.

The use of stage props will be limited to those that will be physically utilized by the participant. No inappropriate visual content or props.

The video is to be a pre-recorded presentation and sent to [program@cweia.ca](mailto:program@cweia.ca) by March 23 at 11:59pm.

#### 5. PANEL AND PUBLIC SPEAKING (Session 3) March 31,2021

A three to five-minute oral presentation based on the Essay topic chosen. Oral presentations are **spoken** words. Oral presentations **shall not** include the following: singing, sign language, dancing or audience involvement. Oral presentations which are over five minutes will be penalized 10 points.

Participants will also be asked one or two random questions which will be drawn from a hat. They will be judged on how well they respond to the questions.

For your Essay:

- Format essay: Typed with a minimum of 200 words and not more than 500 words. Emailed in PDF format to [program@cweia.ca](mailto:program@cweia.ca)
- The content of the essay should also include recommendations.
- The cover page should contain: Title of the essay, participants name and community.
- Essay must be clear, organized and effective.
- Essay must reflect the use of good grammar and punctuation.
- Essay must flow smoothly and logically
- Essay conclusion must be logical.
- Submission of the essay is to be submitted with the application (March 29, 2021 at 11:59pm) by email to [program@cweia.ca](mailto:program@cweia.ca)

#### 4. TRAVELING TO MEEI LIVE PAGEANT – APRIL 17, 2021

##### Travel

CWEIA will offer \$0.30/km.

##### Meals

Each participant and coach will have their meal reimbursed.

### **Lodging**

You will be placed in a hotel if available, otherwise you will be offered \$40 per night for private lodging. If private lodging is used, Local Women's Association or CWEIA will make sure you are placed in a comfortable home.

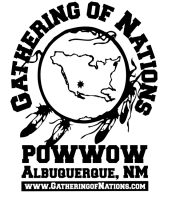

- I am representing my family, my Tribe(s) and myself. It is very important for me as a Miss Indian World (MIW) contestant and an individual; to maintain certain moral standards for myself now and in the future.
- I will conduct myself in a professional manner that is above and beyond reproach during my time as a MIW Contestant. Behavior unbecoming and noted, **will result in disqualification as a Miss Indian World Contestant.**
- I affirm that I have no dependents (children, adopted, foster or by guardianship) and have never given birth to or conceived a child.
- I affirm that I have never been married (legally or through Native Marriage).
- I should have a positive attitude about myself before, during, and after the Miss Indian World Pageant. I will be required to respect, cooperate, and participate with fellow contestants, the Miss Indian World Committee, Judges, Gathering of Nations Pow Wow staff and the Public Relations firm that works with GON/MIW and anyone else I may come in contact during my time as a MIW Contestant.
- I am required to be in Albuquerque, New Mexico, U.S.A. for the Pageant Orientation on **EVENING, APRIL 2022**. I must be accompanied by a parent or chaperone who is 25 years or older at the Orientation. Itinerary & Schedule of Activities will be sent to you.
- **I must sell a minimum of 500 Raffle Tickets to be considered a Miss Indian World Contestant.** This is in lieu of a Pageant Entrance Fee.
  - a. **I must turn in any unsold tickets including the money you raised from my sales during Registration. Failure to do so will result in immediate disqualification.**
  - b. **I am solely responsible for the Raffle Tickets assigned to me.**
- **I am responsible for my personal belongings at all times.** The Miss Indian World Committee and the Gathering of Nations are NOT responsible for Contestant’s belongings, loss, theft and/or injury.
- **I understand that should I become Miss Indian World, I must keep my personal relationships private and understand that at no time can my significant other be considered a chaperone or travel with me on official Miss Indian World Trips and/or appearances.**
